From the Mayor

Town Manager Sanford Daily announced his plans to retire at the end of the year at our November 18, 2019 Council Meeting.

Mr. Daily joined the Town in April 2008, when former Mayor, Pete Fosselman, advocated for a professional manager to oversee the day-to-day operations of the Town. Previously retired from the City of Gaithersburg after 27 years, Mr. Daily was persuaded to come and work for the Town.

I have had the privilege of working with Mr. Daily since 2012, when I was first elected to the Town Council. With his many years of municipal management experience, Mr. Daily has served our Town exceptionally well and with the highest level of professionalism. Our elected officials, Residents, and the Town staff will miss his steady

hand and institutional knowledge.

Mr. Daily's last day as Town Manager will be December 31st, however, at the request of the Council, he will remain on staff as a consultant through March 2020. Assistant Town Manager Matthew Hoffman will become acting Town Manager beginning January 1, 2020.

The Board of Appeals issued a denial for oral arguments and conditional use (self-storage) for the property located at 10619 Connecticut Avenue on October 29, 2019. The applicant, 1784 Capitol Holdings, has 30 days to appeal the decision to the Circuit Court of Maryland.

On behalf of the Town we wish a happy and safe Thanksgiving.

Strosnidars Hardware ran a round-up program during the month of October where customers were able to round up their purchases to the next dollar amount, with that difference being donated to the Kensington Volunteer Fire Department. In total they raised \$1,934. Strosnidars also hosted a Steak Cookoff competition where they donated several grills and grilling accessories to be raffled off; these proceeds were also donated to KVFD, totaling \$884. Amy Hart, events coordinator at Strosnidars, presented a \$2,818 check to KVFD Treasurer David Breitman. These funds will go towards purchasing a new Ambulance.

Town Minutes Summary

October 7, 2019 Work Session and Town Council Meeting

- Held a Work Session to discuss language and possible restrictions for State Legislation to adopt Montgomery County's alcohol regulations.
- Approved the Closed Session Minutes from August 14, 2019.
- Approved the Town Meeting Minutes from September 9, 2019.
- Adopted Resolution No. R-18-2019 - A Resolution of the Mayor and Town Council authorizing the Town Manager to install "4 Hour, 7:30 am - 5:30 pm, M-F" signs on the east side of Carroll Place and the west side of Montgomery Avenue adjacent to 10237 Carroll Place (Noyes Children's Library).
- Adopted Resolution No. R-19-2019 - A Resolution of the Mayor and Town Council to allow the establishment of a Dog Exercise Area and provide regulations for its use.

October 28, 2019 Special Town Council Meeting

- Approved an amended Memorandum of Understanding with the Maryland Department of Transportation State Highway Administration for the maintenance and landscaping of the median along MD 185 (Connecticut Avenue).
- Approved comments, as recommended by the

Maryland Municipal League, to oppose any further federal regulations that would impede local governments from exercising land use authority to regulate small wireless infrastructure.

Summit Ave Extension

There has been some discussion recently, on neighborhood listservs and at public meetings, about what is the Summit Avenue Extension. I wanted to provide a little background and explain why I and others on the Town Council have consistently supported this project.


The Need

To put it mildly, traffic coming through Kensington is atrocious. The Montgomery County Department of Transportation (MCDOT) considers the intersections of Connecticut & Knowles and Connecticut/Plyers Mill/Metropolitan to be failing, and failing badly. What makes traffic along Connecticut Ave. so congested between Knowles Ave. and Plyers Mill Rd. is that all north/south traffic along Connecticut Ave. and University Blvd. and all east/west traffic along Plyers Mill Rd. and Knowles Ave./Strathmore Ave./Cedar Rd. must combine and share the approximately 2 block area along Connecticut Ave. from Knowles until the Connecticut/University split north of Plyers Mill Rd.

The congestion problems worsen continually. Some people have pushed for a moratorium on new development in Kensington until the county or state address the congestion. That idea has a superficial appeal—until you realize that our roads carry 60,000 cars through this town of 2,000 residents. Large-scale development is happening outside of Kensington that contributes orders of magnitude more through-traffic than local projects will. Just in the last few years, development to the north includes Metro Pointe (121 units) and the Exchange (486 units) in Wheaton and to the south includes the Chevy Chase Lake, a mixed-use development set to open in 2021 and include 280 apartments, 65 condominiums, and over 100,000 square feet of retail as well as the growing campuses of the National Institutes of Health (NIH) and the Walter Reed National Military Medical Center. We desperately need to address the increased through-traffic with increased capacity on the roads.

The Project

The Summit Avenue Extension would alleviate a



lot of the congestion along Connecticut Ave. by providing a bypass away from the intersection of Connecticut & Knowles. Southbound Connecticut Avenue traffic that wants to turn right onto Knowles would be diverted away from this congested intersection. Similarly, eastbound Knowles traffic that wants to turn left to head north on Connecticut would be able to do so way back at Summit Ave. rather than feeding into this intersection.

If you think about afternoon rush hour, traffic from the west has two options—go to Connecticut and turn left, or head up existing Summit to its dead-end at Plyers Mill and then turn right towards Connecticut. Both are extremely congested. The Summit Avenue Extension would retain these existing two access points to Connecticut, and would add Dupont and Farragut. This will allow a large volume of traffic that is passing through Kensington to do so more efficiently, thus reducing congestion, wait times, and backups. Additionally, it will provide additional options for north side residents to cross Connecticut Avenue to get to/from home in the morning and evenings. However, the Town will not allow straight-through traffic from the Summit Avenue Extension along Farragut from west of Connecticut/University to the residential area to the east.

Summit Ave Extension

The design of the Summit Avenue Extension centers on creating two additional returns to Connecticut Ave for north/south traffic north of Plyers Mill. This design will allow traffic to 'by-pass' the central retail corridor of Kensington along Connecticut Ave between Knowles and Plyers Mill providing the greatest opportunity for traffic congestion relief in the center of Kensington.

The Summit Avenue Extension will not be a "silver bullet" that cures all congestion. MCDOT projects that it will divert 10% of traffic from Connecticut Ave. to Summit Ave. However, this 10% diversion means 6,000 - 6,500 fewer cars traveling Connecticut Ave. between Farragut and Knowles Ave. each day.

The project also presents the opportunity to spur commercial redevelopment along its route. The commercial businesses currently located adjacent to KenGar between Connecticut Ave. and Summit Ave. are predominantly automobile repair services. A new roadway, with sidewalks and bike lanes will be an opportunity to revitalize this area with retail shops that cater to nearby residential neighborhoods.

The Summit Avenue Extension is a county project (because it is the improvement and extension of a county road), but it provides relief on state roads (Connecticut and Knowles) and would benefit the Town of Kensington, which is ground-zero for terrible congestion. The Town Council has repeatedly voiced its support for this project (for example, in a unanimous vote on October 8, 2018), and fought to maintain funding in the County budget to keep the development of this project moving forward. Most of our District 18 state delegation supports this project, as do our County councilmembers.

Alternatives

In short, there are no alternatives that provide significant relief for traffic coming through town on Connecticut Ave. The traffic flow is largely north-south, and that traffic has to cross the east-west CSX train tracks. The roads in this vicinity that cross over the train tracks are Connecticut Ave. and Summit Ave.

To be sure, there are some short-term improvements that MCDOT is studying and working to implement, given that the Summit Avenue Extension is


probably 5-7 years off. These include lengthening a southbound turning lane on Connecticut above Plyers Mill, as well as lengthening the turn lane on eastbound Plyers Mill for traffic turning left at Connecticut. The Town Council is supportive of these short-term improvements and is working with MCDOT to see that they are implemented. But, these short-term initiatives offer only marginal, directed improvements to specific intersections and are no substitute for the major infrastructure improvements that will improve the flow of traffic across the major traffic arteries that crisscross Kensington.

The Future

MCDOT has held several meetings to discuss the Summit Avenue Extension, and will hold several more as it continues to study and develop the proposals. Anyone who is interested in learning about the project or who wants their views to be considered should participate in the public meetings where the project is being discussed and developed. Now is the time, during the Phase II study of the project, to make suggestions on how this project can proceed but be improved to have minimal negative impacts in the area.
