July 13, 2020 Organizational Meeting 6:00 p.m. by Zoom Video Conferencing

Council Members Engle and Hill-Zayat were sworn in prior to the Organizational Meeting by Mayor Furman.

Mayor Furman, Council Members Bartram, Crimmins, and Engle, Town Manager Hoffman and Clerk-Treasurer Engels were present. Council Member Hill-Zayat was necessarily absent.

The Council concurred to meet with the State Highway Administration (SHA) and Montgomery County Department of Transportation (MCDOT) to discuss the development and traffic along the Knowles Avenue corridor.

A sub-committee of the Board of Supervisors of Elections will be added to evaluate the past election and consider changes, to include: non-citizen eligibility, future vote by mail elections, and addressing an uncontested election. The sub-committee will include Council Members Bartram and Engle, along with the Board of Supervisors of Elections.
