We understand that many residents may prefer to vote by Absentee Ballot instead of in person on Monday, June 6, 2022. For this reason, the Town will be mailing an Absentee Ballot Application (this is not an actual Ballot) to every registered voter within the Town. If you prefer to vote by Absentee Ballot, the Application must be completed and returned to Susan Engels, Clerk-Treasurer, to receive an actual Absentee Ballot.

We recommend that the Absentee Ballot Application be returned by email to: Susan.Engels@tok.md.gov, or directly to Town Hall at 3710 Mitchell Street, during regular business hours: 8:00 am – 4:00 pm, Monday – Friday. Otherwise, the Absentee Ballot Application may be mailed to the following address: Town of Kensington, PO Box 619, Kensington MD 20895.

If you are registered with the Montgomery County Board of Elections, you are registered to vote with the Town of Kensington. If you are not registered with the Montgomery County Board of Elections, you may register directly with the Town for Town Elections only, by completing our Supplemental Registration Form available at the following link: tok.md.gov/wp-content/uploads/2022/05/Supplemental-Registration-Form-FINAL.pdf and returning the completed Supplemental Registration Form to Susan Engels by 4:00 pm on Tuesday, May 31, 2022.

VOTER QUALIFICATION: Every person who is a citizen of the United States, or who is not a citizen of the United States but is a permanent resident or is authorized to work in the United States, is at least 18 years of age, has resided within the corporate limits of the Town for thirty days, and is registered in accordance with the provisions of the Town Charter, shall be a qualified voter of the Town and shall be entitled to vote at any or all Town Elections.

Once the Absentee Ballot application has been received by the Clerk-Treasurer, an Absentee Ballot will be mailed to the applicant with detailed instructions. **Please** follow the instructions carefully. Absentee Ballots may be returned by mail using the enclosed envelope or through the Town's drop box located at Town Hall. Due to construction at the front entrance of Town Hall, the drop box has been temporarily relocated to the south-east side of the building adjacent to the public parking lot.

All Absentee Ballots must be received by 9pm on Monday, June 6th, 2022.

Ballots received after 9pm will not be counted.



Inaugural Juneteenth Celebration Brings History to Life in St. Paul Park

Like most Americans, Jamie Boston thought he knew what was in the Emancipation Proclamation. When he sat down with his young daughters to read it all the way through—in preparation for his family’s Juneteenth celebration last year—the retired combat veteran and U.S. Army JAG found an entirely different document than he expected.

Lincoln’s 1863 Proclamation “wasn’t so much about freeing slaves, it did that to a degree” Boston reflected, “but it was really an invention by President Lincoln to create presidential war powers.” The Proclamation, he said, was intended to free enslaved people and outlaw slavery in the rebel states to diminish the resources and manpower that slavery provided, and to allow enslaved people to join the Union army. Thus, the goal was ultimately to defeat the rebellion.

“When one reads the Emancipation Proclamation,” Boston explained, “one soon realizes that the states who had slaves but were in support of the Union were generally left alone.”

One of the states left alone by the Proclamation was in fact Maryland, which did not abolish slavery until one year later, in 1864. Understanding that emancipation was a political tool that did not end of slavery in Maryland shapes our understanding of the past—and the present. “This is the part that’s glossed over,” said Boston, referring to the myth that Emancipation brought true freedom for everyone. “There’s more to the story and this complete story is ALL Americans’ history.”

Boston was inspired by his family’s celebration of Juneteenth last year to make the history of Juneteenth come alive for a broader audience. A Kensington resident since 2020, after being encouraged by his neighbor, State Delegate Emily Shetty, and then being connected with Councilmember Nate Engle, Boston was introduced to Mayor Tracey Furman and the Racial Justice Committee, who enthusiastically agreed to bring Juneteenth to the Town of Kensington.

“The Federal holiday of Juneteenth commemorates the ending of slavery in the United States,” said Mayor Furman. “We want to celebrate emancipation in Kensington, of course, and to celebrate the diversity of our community, but we also want to recognize that there is still work to be done.”

When asked why he wanted to bring his celebration to Kensington, Boston spoke of his love for his new hometown, the fact that his neighbors were “all different colors of the rainbow,” and the strong sense of community that was a gift to him and his family when they settled here.

On a more somber note, Boston also spoke of the polarization gripping the nation, the ways in which political differences have been essentialized, making it hard for people to make overtures across the aisle and create fellowship. “It will take a community like Kensington to bring this divided country back together,” he said. “We just have to start talking.”

The celebration, scheduled to take place in St. Paul Park on June 18 from 12:00-4:00 p.m., will feature food vendors, beverages, informational booths, historical reenactors, and free live and DJ music from gospel, jazz, folklore, and contemporary genres. And of course, there will be a reading of the Emancipation Proclamation.

“Fun with a purpose,” said Boston.

Don’t miss the Town of Kensington’s Inaugural Juneteenth Celebration, taking place June 18, 2022 from 12:00-4 p.m., in St. Paul Park, with a rain date of June 19th. The street address of the park is 10564 St. Paul Street, Kensington, MD 20895.



FY23 Budget Ordinance



Budget Ordinance No. O-02-2022
Introduced: March 14, 2022
Public Hearing: April 11, 2022
Adopted: May 9, 2022

AN ORDINANCE OF THE MAYOR AND TOWN COUNCIL OF KENSINGTON TO APPROPRIATE AND ADOPT THE FISCAL YEAR 2022 – 2023 (FY23) BUDGET AND TO LEVY A TAX ON CERTAIN REAL AND PERSONAL PROPERTY UNDER THE PROVISIONS OF §6-203 OF THE TAX-PROPERTY ARTICLE OF THE ANNOTATED CODE OF MARYLAND, AS AMENDED.

WHEREAS, §5-205 et seq. of the Local Government Article, Annotated Code of Maryland, authorizes the Mayor and Town Council to provide for the control and management of its finances and expend money for any public purpose and for the safety, health, and general welfare of the Town and its occupants; and

WHEREAS, §6-203 of the Tax-Property Article, of the Annotated Code of Maryland (as amended), grants authority to municipal corporations to levy a tax on personal property, land, and improvements thereon, within the municipal corporation; and

WHEREAS, Article VIII, “Finance”, Section 801, “Fiscal Year”, of the Town Charter states that the Fiscal Year of the Town shall begin on July 1, 2022, and end on June 30, 2023; and

WHEREAS, Section 802, “Proposed Budget”, of the Town Charter states that the Town Manager shall submit to the Council prior to the third Monday in April, a Budget of anticipated revenues, proposed operating expenditures, and proposed capital project expenditures, along with a written financial plan for the succeeding fiscal year; and

WHEREAS, Section 803, “Adoption”, of the Town Charter states that prior to adopting the Budget, the Council shall hold a public hearing following due notice and a favorable vote of at least a majority of the total elected membership of the Council shall be necessary for adoption.

NOW THEREFORE, the Mayor and Town Council of Kensington does hereby adopt the following Budget Ordinance:

AN ORDINANCE TO APPROPRIATE AND ADOPT THE FISCAL YEAR 2022 – 2023 (FY23) BUDGET AND TO LEVY A TAX ON CERTAIN REAL AND PERSONAL PROPERTY UNDER THE PROVISIONS OF §6-203 OF THE TAX-PROPERTY ARTICLE OF THE ANNOTATED CODE OF MARYLAND, AS AMENDED.

SECTION 1:

BE IT ORDAINED AND ORDERED this 9th day of May, 2022, by the Kensington Town Council, acting under and by virtue of the authority granted to it by §5-205 et seq. of the Local Government Article, Annotated Code of Maryland, and Article VIII of the Kensington Town Charter, that the budget for Fiscal Year July 1, 2022 through June 30, 2023, attached hereto and incorporated herein by reference, be and the same hereby is appropriated and adopted.

SECTION 2:

AND BE IT FURTHER ORDAINED AND ORDERED, this 9th day of May, 2022, by the Kensington Town Council, acting under the virtue of the authority granted to it by §6-203 of the Tax-Property Article, of the Annotated Code of Maryland (as amended), and Article VIII of the Kensington Town Charter, hereby levies a tax at the rate of One thousand, three hundred twelve ten-thousandths cents (\$0.1312) per One Hundred Dollars of full value assessment on all taxable real property located within the corporate limits of the Town of Kensington.

SECTION 3:

AND BE IT FURTHER ORDAINED AND ORDERED, this 9th day of May, 2022, by the Kensington Town Council, acting under the virtue of the authority granted to it by §6-203 of the Tax-Property Article, of the Annotated Code of Maryland (as amended), and Article VIII of the Kensington Town Charter, hereby levies a tax at the rate of eighty cents (\$0.80) per One Hundred Dollars of full value assessment on all taxable personal property located within the corporate limits of the Town of Kensington.

SECTION 4:

AND BE IT FURTHER ORDAINED AND ORDERED, this 9th day of May, 2022, by the Kensington Town Council, acting under the virtue of the authority granted to it by §8-101 of the Tax-Property Article of the Annotated Code of Maryland (as amended), and Article VIII of the Kensington Town Charter, hereby levies a tax at the rate of five dollars (\$5.00) per One Hundred Dollars of full value assessment on all taxable personal property set forth by §8-101 of the Tax-Property Article, of the Annotated Code of Maryland (as amended):

1. Operating personal property of a railroad;
2. Operating personal property of a public utility that is machinery or equipment used to generate electricity or steam for sale;
3. All other operating personal property of a public utility; and
4. Machinery and equipment, other than operating personal property of a public utility, that is used to generate electricity or steam for sale or hot or chilled water for sale that is used to heat or cool a building.

SECTION 5:

AND BE IT FURTHER ORDAINED AND ORDERED, this 9th day of May, 2022, by the Kensington Town Council, hereby adopts the imposition of a full-year, one-half year, three-quarter year, and one-quarter year tax levies, authorized pursuant to §10-102, 10-103, 10-104, and 10-105 of the Tax-Property Article of the Annotated Code of Maryland (as amended), and authorizes and empowers Montgomery County, Maryland, to collect and remit the same to the Town of Kensington, consistent with the imposition and collection of such levies on real property by Montgomery County.

AND BE IT FURTHER ORDAINED AND ORDERED, this 9th day of May, 2022, by the Kensington Town Council that the transfer of funds by Resolution within the Operating and Capital Improvements Budget may occur.

AND BE IT FURTHER ORDAINED AND ORDERED, this 9th day of May, 2022, by the Kensington Town Council, acting under and by virtue of the authority granted to it by §5-201 et seq. of the Local Government Article, Annotated Code of Maryland, and Article VI, "Powers of the Council", Section 601, "General Powers" of the Town Charter that:

- (1) If any part of provision of this ordinance is declared by a court of competent jurisdiction to be invalid, the part of provision held to be invalid shall not affect the validity of the ordinance as a whole or any remaining part thereof; and
- (2) This ordinance shall take effect on the 1st day of July, 2022, provided the following:
 - (a) Posted at Town Hall by the next business day following introduction; and
 - (b) Posted on the official Town website; and
 - (c) Sent to those persons listed on the official Town email list/mail subscription service; and
 - (d) Published once prior to the public hearing in the Town newsletter or sent by substitute regular mail to newsletter circulation addresses.

INTRODUCED by the Mayor and Town Council of Kensington, Maryland at the regular public meeting assembled on the 14th day of March, 2022.

ADOPTED by the Mayor and Town Council of Kensington, Maryland at the regular public meeting assembled on the 9th day of May, 2022.

EFFECTIVE the 1st day of July, 2022.


