- 1. <u>Introductions</u>
- 2. Walkability/bikeability audit progress and prioritization
 - Alan updated on the segments and thanked everyone for their efforts. All 108 are done (which is several dozen more than the first audit), as of February 23.
 - NE3032 segment: St. Paul between Plyers Mill and Oberon. Seems to be extra information in addition to what Marla did. All, anyone know who did this segment? If not, Leslie will look at and reconcile them.
 - Jon updated on prioritization quantification process he conducted to provide a decision support tool, based on the recently adopted vision statement. Scored each of the segments, based on several metrics: repairing barriers, locations with vulnerable users (parks, schools, older adults), existing and planned retail areas, and high crash locations. He did it for all segments across three of the metrics.
 Jon to add the high crash locations to the list.
 - Jon, Alan, and Nate to discuss and provide clear guidance for the WG on how to finalize this quantification process by combining it with several other factors for filtering out the priorities (i.e., 2-3 priority actions each WG member who audited streets wants to flag, but might not have been captured in a high-scoring street from Jon's quantification process, as well as "simple fixes" that could be provided to the Town for regular maintenance schedules).
 - Next audit in two years could already include these prioritization categories from the get-go so it's more streamlined when we do the audits.

3. Communication and education – 1-pager and slogan

- Discussed the eight options printed on the poster board. Agreed on E and G, with some additions
 marked on the papers. Nate to convey to Kariann and Tracey so they know the final two designs,
 and so that tweaks can be made for final review at the March meeting.
- 1-pager was not discussed. Chris Q. to send around the draft for final review amongst the WG before placing on website.
- Discussed possible ideas for changing the name of the group. PBAS-WG and "Kensington At your Feet" were mentioned. **All members to send ideas for potential name changes of the WG.**

4. County Pedestrian Master Plan feedback/testimony

- Requested for everyone to have a quick review if possible, and flag high level issues that resonate, as well as specific points pertinent to Kensington, and/or anything missed that we want to have them prioritize that may not be in there. **Everyone to share with Nate by March 10**th.

5. Packaging as "campaigns"

6. AOB (AII)

- Nate testified on behalf of the Town for Senator Waldstreicher's SAFE Roads Act (SB16) earlier in the month. The legislation will codify MDOT SHA's Context Driven Design guidelines.
