

#### **Greenscape Committee**

We've all heard many times that we need to pick up our dog's waste on a public site. After all, nobody wants to see it or step in

it--and it's the law. We're fortunate in Kensington to have 21 pet waste stations installed and maintained by the town crew, making disposal quick and easy on town streets. So why do we need another article about this topic?

There may be a good deal more you need to know about why and how to dispose of your pet's

waste on public and on private property (yes, even in your own yard). Do you know that the average dog produces about 248 pounds of waste a year?

Pet waste carries bacteria, including salmonellosis, toxocariasis and toxoplasmosis. Other pets, children playing outside and adults gardening are at risk for infection from these bacteria and from parasites found in pet waste.

Pet waste does not fertilize your yard or "disappear" over time. Every time it rains, pet waste is dispersed into our soil, storm drains and waterways. Bacteria and parasites in it are spread and more animals

and people are put at risk. The nutrients in it also affect water quality, encouraging excess weed and algae growth and contributing to making the water cloudier and greener. These excess nutrients also use up oxygen and can release ammonia, adding to water quality decline that is killing fish and other aquatic life.

A study by the USGS in Kansas City recently shows that bacteria associated with pet waste was the source of approximately one-quarter of the bacteria in samples collected from local waterways. While these points may seem alarmist, think about how many pounds of waste are produced just on your street and can add to water quality decline!

So what should you do instead of leaving it where your dog chooses? Carry disposable bags (preferably biodegradable) and pick up your dog's waste. Wrap it up tightly and put it in one of the public dog waste bins or carry it home and put it in your trash (still wrapped up), not the recycling bin or compost. Never put it in a storm drain. Your actions can help make your pet, your family, our community and our environment safer.



## Woman's Club of Kensington





#### Woman's Club of Kensington 125 Years of Continuous Service To Kensington

As reported in the 1900 Census, there were about 1.2 million people living in Maryland with the population of Montgomery County at about 30,000 and the Town of Kensington with a population of 477. The Town had no paved roads, no electricity, no telephones,

no street signs or house numbers. But, of those 477 Kensington residents, approximately 30 (the membership was capped to permit meetings in members' homes) were members of the Woman's Club of Kensington (WCK) which was formed in October, 1899 and has been active since that date. WCK is celebrating this 125th anniversary at the October Club meeting with a panel presentation which will be filmed by MMC. Many names of the early members of the Club are immediately recognizable today as founders of the Town.

The WCK will share that amazing history over the next several issues of the Town Journal. The WCK Collection in the Kensington Town Archives is complete with records from the very first meeting of the WCK. Not only did the ladies (who declared they would refer to themselves as women in 1902) have a very active Club whose initiatives help build the fabric of Kensington, they knew the value of recording and archiving the Club history. This installment will chronicle the Club from inception to about 1930.

The first meeting was at the Cummingham home at the corner of Howard and Fawcett. From the onset they observed Roberts Rules of Order and had what was called Parliamentary Drills regularly. When roll call was done each member had to respond with a literary quote. Some of the first-year programming (written and presented by members) included such topics as Prehistoric America; Life among the Zunis; Spanish Conquests and Settlements; Indians and early Indian Wars; War with Tripoli and purchase of Louisianna etc. In the days before Google and Wikipedia that represented a lot of research. The first annual banquet was in 1900 with the theme of the Causes of the Revolution.

Early on the Club met twice a month with each agenda packed with substantive presentations and discussions. In addition to pursuing intellectual matters, the efforts of the Club extended throughout the Kensington community and beyond.

In Kensington, for example, they installed the first ashcan at the Post Office, landscaped around the Post Office and sought to save the Kensington Cabin, and saw that the Town installed cinder streets and street signs. They made nurses and social workers available to residents of Town and KenGar. They worked to improve the schools (including segregated schools) by paying for janitors, improving kitchens and creating school libraries and funding art teachers and school lunches. The Club supported compulsory education. They were very active in working with the school in KenGar to improve the facility on many levels. They helped to start the Town library. They were also concerned with saving songbirds in Town and debated the wearing of feathers in hats. They pressured the trolley company to build protection from the elements for motormen and conductors.

The Club took on many initiatives in Town that improved living conditions for all residents but the scope of the Clubs interest did not stop there. They advocated at the County, State and National level on a variety of issues. In 1916 the Club endorsed the National Park Service. In 1920 they lobbied for kindergarten in the schools and a juvenile court. In 1924 they were part of the World Court movement and advocated for special buildings for women prisoners, opposed a dam in Yellowstone and supported the preservation of the upper Mississippi River. They worked for change in child labor laws, universal peace, uniform marriage and divorce laws, jury service for women, old age pensions and police protection for Kensington, advocated to have a woman on the school board and to have women's wards in hospitals. In 1913 they supported raising the legal age to marry from 16-18 years.

They endorsed a bill against "expectoration in street cars".

In addition to the charitable and civic work the Club did directly, the benevolence work started very early on. As early as 1907 they established a scholarship fund. They worked on many social service projects through the General Federation of Women's Clubs and the Social Service League. Much of the work focused on schools, libraries and the judicial system. They raised money for the fire department, the Thrift Shop in Town, the building fund of Children's Hospital and supported children in the County home. They donated to causes outside the area such as historic preservation, famine and earthquake relief.


During WW1 the Club women were very active in supporting the war effort. They regularly provided the

1st Maryland Infantry with various shipped supplies overseas, maintained victory gardens. supported care for war orphans and financed Liberty Bonds.

The creation of the Club and the dedication of the members to Town and other causes represented a shift in the family dynamics - to say the least. In 1904 the husbands responded (with good humor) by forming the Married Men's Protective Association. and producing the flyer you see in the article and sending the youngest of one of the members five sons to sing a song pleading "O, Mother, dear Mother, come home". The women responded with a ditty performed at a banquet.

Right from the beginning, the women of the Woman's Club of Kensington exercised their intellect, took action when they saw ways to improve the Town for all residents and to advocate where they saw change was necessary at a much broader level. The Town felt the benefit of their efforts immediately and tangibly.

As I mark my first year as archivist for the Kensington Town Archives on October 3rd, I'm proud of the strides we've made in preserving Kensington's history and making it accessible for future generations.

This past year's key achievements include:

- A fresh new look: updated paint, flooring, and shelves meeting archival standards.
- Formalized policies and procedures for long-term custodianship and care.
- · Comprehensive collections assessment to review documentation and prioritize processing.
- Rehousing of collections into protective folders and boxes to safeguard against damage.
- Hosting a successful Open House on July 11th, featured on Montgomery Municipal Cable.
- Over 100 hours dedicated to remote reference and in-person research support.
- Creation of exhibits and posters for educational outreach.

Collaborating with the Kensington Historical Society, we've:

- Provided digital access to Kensington: A Picture History in a searchable PDF format.
- Developed a new oral history program and digitized previous recordings on cassette.
- Launched a Conservation Fund to support specialized conservation efforts.

Looking ahead, my goals for 2024-2025 include:


- **Rehousing:** Further improve storage with specialized materials.
- Accessioning: Complete formal transfer of collection custody, identifying origins, donors, and access restrictions.
- Finding Aids: Create a website featuring collection listings for enhanced research support.

#### Parking Task Force Nomination



#### Kensington's Parking Task Force: Addressing Our Growing Community's Needs

The recent growth of Kensington's commercial district has brought many benefits to our town, including new businesses, jobs, and services. However, this growth has also increased demand for parking, sometimes causing congestion and conflicts between residents and visitors, especially where commercial areas meet residential streets.

To address these challenges, the Mayor and Town Council have established a Parking Task Force. Its mission is to:

- 1. Research and analyze current parking capacity and needs, especially on the town's southeast quadrant.
- 2. Develop recommendations for the Town Council on managing current and future parking demand.
- 3. Identify strategies to alleviate parking congestion and conflicts, and improve mobility in Kensington.

The Parking Task Force will consider short-, medium-, and long-term solutions to ensure our town can accommodate growth while maintaining its character and livability.

#### Join Kensington's Parking Task Force

Councilmembers Conor Crimmins and Ann Lichter will co-chair the Parking Task Force. To ensure diverse representation, we're seeking nominations from Town residents and business representatives, with a desire to have representation from each quadrant of the Town (please see map for explanation of quadrants).



## Fall Leaf Pick-up Schedule



The Town will begin its annual leaf collection Monday, November 4, which runs through Friday, December 13. There are no scheduled collection zones, as the Public Works Crew will monitor each street on a daily basis.

Please gather leaves **INSIDE THE CURB** as shown with a green check.

Please **DO NOT** put leaf piles in the streets. **DO NOT** include grass clippings, mulch, twigs, or small branches within leaf piles, as this may damage our leaf vacuum. If your leaf pile contains any materials besides leaves, the Crew will not collect your pile, and you will be responsible for bagging the leaves on your own.





#### **Leaf Composting!**





As an alternative to bagging up your leaves or piling them at the curb, consider using a mower to chop up the leaves and either leave them on your lawn or move them to your garden to nourish the soil. You can also put the leaves in your garden beds to insulate perennials and provide an important habitat for pollinating insects through the winter.
