THIS DEED Made this <u>316</u> day of October, A.D., 1956, by ARTHUR C. HYDE and MARY ANN HYDE, his wife, hereinafter called the Grantors, to THE TOWN OF KENSINGTON, a municipal corporation, hereinafter called the Grantee.

NOW, THEREFORE, THIS DEED WITNESSETH, That for and in consideration of the sum of Ten Dollars (10.00), and other good and valuable consideration, receipt of which is hereby acknowledged, the said Grantors hereby grant and convey unto the said Grantee, its successors and assigns, in fee simple, forever, all of the following described lands and premises, situate in Montgomery County, Maryland, being all that lot or parcel of land situate lying and being in said Montgomery County, Maryland, known as described as the easterly 125 feet front on Flyers Mill Road, by the full depth of 60 feet on Wheatley Street of Lot numbered One (1) in the subdivision known as W. H. Wheatley's Subdivision of Part of Joseph's Park as per plat recorded among the Land Records of said Montgomery County, Maryland, in Flat Book A, plat 22, described as follows, to wit:


